# a) Property Room Forfeitures

Under the new act the board can choose where the extra money goes from seizures from drug money that is dealt with before the courts and the money comes back to the municipality from proceeds of crime. There are funds available at this time.

# b) Grant Updates

Some upcoming grant opportunities- we will be applying for the new CISO/ POC grant in August.

MCRT Grant the next year funding for the 3-year cycle.

NG911 Year 3 is coming out and we will be applying for that as well.

Proceeds of Crime Grant is going into year 2 that we do with Big Brother & Big Sisters.

CSP Local and Provincial 2025 will wrap up these grants.

Victim Support grant will be coming out soon for us to apply for.

#### C) Recruitment

To keep staffing levels adequate with the new act- we have requested to hire two more Constables that are experienced. This will help us keep up with the call volume and the seriousness of the calls for service without burning the officers out and offsetting the overtime budget.

- J. Aunger- with the community growing we need to keep the complement of officers to that matches the growth of the community.
- C. McGuire- Doing the budget update and seeing how high the overtime is riding I think this will be a good way to keep the costs under control.
