Overtime is on the high side- Training, staffing and Illness Legal for the board is on the higher side.

b) Budget 2025- Chief

Still working on the 2025 Budget- Met with the Town just waiting on the salary lines as well as had to wait on the association contract to be ratified. Waiting on information regarding the new water tower to see if money needs to be put aside for 2025 or put off to 2026 for our capital budget. CAD mapping was also discussed — we are WAY behind in mapping for the emergency services at least 8-10 years. The cost for the CAD mapping is around \$80,000. This should not fall on just police, the other emergency services, or the municipality. Reached out to Owen Sound to see if they have a more cost effective way for mapping. Looking into Owen Sound for Owen Sound to take over the IT infrastructure, as they are a fraction of the cost for 2025. Full budget for November meeting.

c) Ratification of collective agreement update

J. Aunger: After a number of month of negotiations, it was great to work with the association. The asks from the association were not crazy: some that were doable some that were not.

Quick overview:

Salary is in line with the OPP @ 98% Increase in Psychological benefits- taken to the max One family wellness day

d) Grant Update- Chief

NG911 into Year 3- still pending on Ministry update.

MCRT still waiting to hear if we are successful on this grant.

Court Security Grant ending in 2025- Totaling just over \$34,000, which offsets our Special Constable salary.

CISO- waiting on update

Victim Support Grant- Is up in 2025 but have heard there will be a new grant coming out the request max is up to \$200,000 we will apply for this grant. CSP Grant is over in 2025- this grant offsets about \$75,000 of our Community Safety Officers Salary. Hoping this will be available again.

e) Staffing Update- Chair

With the needs and demands of our community and the population, growing the personnel has not increased for decades. Understanding the sick leave and WSIB-to ensure the needs of the community. The job of the board to make sure we have adequate and effective policing in our community- looking to add to our personnel. Today is to provide approval to hire two new personnel could be recruit or experienced between now and the end of the year. Also to hire two more early into 2025- this will be a budgetary impact.
