Still doing fine with the budget- High in office supplies due to chair purchases. Hoping to be able to use some grant funding to off set these costs. Salary settlements from payouts will be off set from the 2023 budget. Overtime running high- off set some costs from salary recover line.

Looking ahead into 2025- looking at the Capital budget (IT infrastructure) needing to make some upgrades. Looking to purchase a new Intoxilizer 9000 to replace the Intoxilizer 8000 that are being replaced across the province- cost for this is about \$12,000. Breath techs will be trained on the Intoxilizer 9000 unit. Operationally looking to purchase new riffles for the cruisers and a new gun that officers carry.

- Diversity Plan Yipe service would be a great program it's a paid 8-week program. Chief has applied for 4 students for summer 2025.
