Working under the supervision of the Manager of Water & Wastewater , the Chief Operator will support the operations and maintenance of the Water Treatment and Water Distribution facilities in accordance with legislative requirements and approved policies and procedures.

### Key Duties and Responsibilities:

- Performs the responsibilities of the position within the legislative and regulatory standards set out in applicable provincial and municipal regulations, policies and by-laws.
- Provides leadership and supervision of facility staff by organizing, directing, and scheduling facility operations for the water treatment facility.
- Assist the Manager of Water & Wastewater with the development and maintenance of operation and maintenance manuals and standard operating procedures.
- Performs regular inspections of equipment and facilities and completes scheduled maintenance work as required.
- Reports process and compliance issues to the Manager of Water & Wastewater and/or Overall Responsible Operator designate.
- Acts as the ORO designate for plant operations in the absence of the Manager of Water & Wastewater.

#### **POSITION SUMMARY AND SCOPE:**

Working under the supervision of the Manager of Water & Wastewater, the Chief Operator will support the operations and maintenance of the Water Treatment and Water Distribution facilities in accordance with legislative requirements and approved policies and procedures.

### **DUTIES AND RESPONSIBILITIES:**

- Performs the responsibilities of the position within the legislative and regulatory standards set out in applicable provincial and municipal regulations, policies and by-laws.
- Provides leadership and supervision of facility staff by organizing, directing, and scheduling facility operations for the water treatment facility.
- Assist the Manager of Water & Wastewater with the development and maintenance of operation and maintenance manuals and standard operating procedures.
- Performs regular inspections of equipment and facilities according to prescribed maintenance schedules. Record and report defects and/or failures in accordance with approved policies and procedures.
- Assist the Manager of Water & Wastewater with the review and approval of documentation including - invoices, operational reports, equipment records, etc.
- Carries out inspections on safety equipment including self-contained breathing apparatus, safety harnesses, safety retrieval equipment, ropes, fire extinguishers, etc.
- Performs scheduled maintenance work including but not limited to: lubrication, oil changes, shaft and belt alignments, belt tensions, chain tensions, impellors, wear rings, etc.
- Undertakes expenditures in accordance with the municipal procurement of Goods and Services Bylaw # 7850-2004(as amended) for infrastructure works and relevant professional services.
- Supervises contractors working at the treatment facilities and ensure that municipal standards and safety requirements are maintained.
- Responsible for the collection of water samples for in-house and external analysis. Conduct laboratory tests, such as Total Suspended Solids, pH, Cl2

(free and total), Alkalinity, UV transmittance and other parameters in accordance with established procedures.

- Reports process and compliance issues to the Manager of Water & Wastewater and/or Overall Responsible Operator designate.
- Maintains all personal records and log book entries in accordance with approved policies and procedures.
- Participates as the ORO designate for plant operations when Manager of Water & Wastewater requires.
- Participates in the on-call rotation for plant operations outside of normal operating hours.
- Reviews, investigates, and responds to customer concerns and inquiries.
- Perform other duties as may be assigned by the M Manager of Water & Wastewater
